3. He/She will be on probation for a period of two years from the date of his/her joining and his/her services under the Corporation will be liable to be terminated during the temporary tenure by giving one month's notice in writing from either side.

5. He/She will not be entitled for Travelling or any other allowance for joining the post.
6. His/Her appointment is subject to verification of his/her identity credentials, genuineness etc which will be conducted at later stage

and in case, it is found that he/she is involved in any malpractices in the examination process, his/her appointment shall be summarily rejected and appropriate legal action shall be initiated against him/her.
