

- 3) Sri. Girish C, Assistant Director, Regional Office, ESIC, Thrissur – Member





- For the officer at Sl. No.2 (Smt.Padmakumari I), the committee finds that the officer in her online application for transfer had opted ESICH, Ezhukone as her first choice. The committee also finds that as per recommendations of the Transfer Committee dated 21.10.2024 the committee proposed the transfer for equal distribution of the available Senior Nursing Officers with proportion to the bed strength of the 3 ESIC hospitals. The committee also finds that the distance between Ezhukone and Asramam is about 20 Kms only. Therefore the committee recommends that the grievance of the officer need not be considered.

Duly considering the principles/ guidelines stipulated in the Transfer Policy and after due deliberations made over meeting on 27.11.2024, the Transfer Grievance Redressal Committee recommends the above in the cadre of Senior Nursing Officer and the report is submitted to the Competent Authority for acceptance/rejection as the case may be.
